We thank our supporters amidst this global pandemic for your continuous support and unconditional love and faith through our ministry. Although we have all become accustomed to a "new normal" in our daily lives, our love and giving hearts towards abandoned and neglected children remains constant. Now, more than ever, these children are in dire need of our helping hands through prayer and through monetary donations.

YANA LAB (Lost and Broken, yet Loved and Believed)

YANA LAB is a fundraising program that was run between December 2019 through January 2020. Total funds collected (\$1,260) thru sale of YANA Coffee House coupons were donated to Jungsoo Kim, Hayoung Kim, and Soohyun Bae who were discharged from Dongmyung Children's Centers in February of 2020.

In February 2021, additional funds will be donated to three other kids discharged from Dongmyung Children's Centers - Sanghoon Lee, Woomin Shin and Kijoon Park.

Flying Happiness





An annual program that was held from February 7th through the 28th, five students and two social workers from Dongmyung Children's Center were invited to spend an unforgettable journey traveling across the United States. After landing in San Francisco, they took a road trip through Los Angeles, Las Vegas, the Grand Canyon, Moab, Salt Lake City and Colorado Springs before spending the last few days of their journey in New Jersey/ New York.

COVID-19 Emergency Support



During a local search of children's centers in need of support during the Covid-19 pandemic, we were able to identify and provide financial support to Sungnam Children's Center, that was extremely short in food and essential products.

YANA Ministry sent a total donation of \$10,000 to Korea in May of 2020. \$4,000 of that amount was given to 4 students who were discharged from Youngmyung Children's Center, in order to support them financially through the Covid-19 pandemic.

Project Yohan

YANA Ministry received an urgent call for help in the winter of 2019. A child who was discharged from a children's center in Seoul was suffering physically and mentally, in desperate need of help. He has been homeless for years, had no health insurance, and a psychological exam stated that he was suffering from schizophrenia. YANA Ministry decided to support him immediately by providing food, supplies, and a place to stay.

YANA Study Abroad Program

Due to the increasing cases of Covid-19 in the United States, all seven of the YSAP students took online courses from March to June, completing the school year with commendable grades.

After completing two years of language courses in the States, Eunji Shim returned to Korea in June of 2020. We want to thank everyone who supported Eunji through prayer and monetary donations.

We ask for continuous prayer and support for our six YSAP students in the States - (Eunji Choi, Jina Park, Yejin Park, Hyeok Kang, Nayoung Lee and Chaeyon Chang).

Class of 2020

Two of the YANA Ministry students, Yejin Park and Jina Park, graduated in June of 2020 and re-enrolled at new schools.



Yejin Park, YANA Study Abroad Program's (YSAP) first student, started studying Biology/Bio-engineering in September of 2020 at Case Western Reserve University in Ohio. Yejin received a \$150,000 scholarship.

Jina Park, YSAP's third student, finished four years at Bergen Community College and transferred to a 4-year university. Receiving \$36,000 in scholarships, she started studying at the University of California at Riverside in September of 2020.

Virtual SMT 2020



Due to the difficulty in travel during the pandemic, all of the summer mission activities were conducted virtually. The annual summer mission trip to Dongmyung Children's Center, which began in 2008, had to take place virtually through You Tube live. Although physically we were 13 hours apart, we felt a sense of togetherness during this time. It was very unfortunate that we could not be physically together in Korea this year. However, it was amazing to witness the growth of the students who had participated in the ministry for the past 12 years, now volunteering as YANA staff members themselves.

Hanmi Dream Scholarship

Three YSAP students, Hyeok Kang, Nayoung Lee, and Chaeyon Chang, received a Hanmi Dream Scholarship awarded by Hanmi Bank. The \$2,000 scholarship was used to purchase school supplies, including computers.

YANA Coffee House

In an effort to uplift the community spirit that was affected by the Covid-19 pandemic, YANA Coffee House hosted a two-day 'drive-thru Coffee House in June. A 'Three Tenor Concert' was also hosted last October to provide an opportunity for people to meet members of YANA family face-to-face.

Christmas Express







Six YANA staff members traveled to Korea to deliver the Christmas presents donated by the sponsors. Following a two-week self-quarantine period upon arrival in Korea, the members delivered presents to Dongmyung Children's Center, Sungnam Children's Center, and Hanguhreum Center.

YNOT Conference

Initially scheduled for April of 2020, the conference was rescheduled for November of 2021 due to the pandemic. We ask for your continued support and prayer for the success of the conference.

Can My Happiness Truly Last?








